#### PRESIDENT'S REPORT Stella Axarlis AM

Thank you to the Executive and all members who attended our 9 November meeting. It was an excellent meeting and we were privileged to experience the presentation of Rebecca Saunders who has now completed her PhD on the History of Churchill Island.

Dr. Rosalind Jessop represented the Phillip Island Nature Parks CEO, Matthew Jackson and provided us with a comprehensive report on the last two months, which you will be able to read in this Newsletter. As the Environment Manager she answered several questions from our members, for which we were very appreciative.

The most pressing issue for us is the Churchill Island Key Area Plan. Tract Consultants led by Mark Reilly, Masters of Landscape Architecture Melbourne (University) have undertaken this work. There has however been a delay and the report will finally be received, by the Board, at the 28 November meeting. After the Board approves the report for circulation, there will be a period of community consultation and I urge you to participate. The main focus of the afternoon however was to approve the changes to our constitution which were necessary to comply with new government regulations.

We are extremely grateful to Tom O'Dea who has made an enormous contribution to making the necessary changes and to Ruth O'Dea, Christine Grayden, David Maunders and all who gave Tom feedback to complete the work needed.

It was gratifying to note that, after such an extensive period of consultation and deliberations, the motion was carried unanimously and the revised Constitution was approved.

Congratulations to our Curator, Christine Grayden, who is outstanding and volunteers many hours outside her dedicated time and with her volunteers and the Phillip Island Natures Parks staff support did sterling work to present Churchill Island for re accreditation. Thank you all.

The next meeting will be on the 8 February so I hope, as the weather should finally improve, as many of you as possible will attend.

As this is the last report before the New Year I would like, on behalf of the Executive and myself, to wish you wonderful season's greetings and a happy, healthy and successful 2014.

# CURATOR'S REPORT Christine Grayden

Volunteer Brad is restoring the old Sunshine Mackay stationary baler that is used during the Easter Festival. Volunteer Jeff has finished his conservation work on the 1920s seed drill and is now working on the dairy delivery wagon. On behalf of PINP I put in an Expression of Interest to have the Museums Australia Victoria state conference on Phillip Island in April 2015. We await the outcome. I have commenced rewriting the Visitor Centre display to fit it onto six double sided banners to replace the current display which is too large for the area available. Our replica costume maker Cheryl Stratford and student Sandra came last Friday to change the two lady mannequins in the Amess House dining room into summer costumes from their winter ones. Cheryl has also donated a male manneguin who is suitably attired. They are much photographed.

Warren Joel is arriving next Thursday to revalue the National Trust objects currently on loan. This is part of rewriting the agreement between PINP and NT, which is now over 10 years old and needs revision. Two extra p/t staff have been employed on CI to clean the toilets twice per day during the week and do other jobs as needed around CI. They will be helping to put the historic farm machinery up off the ground and onto pavers in the next month. We had our museum reaccreditation inspection in August and are awaiting the final report. Greg the gardener continues to make a difference to the garden, but is **desperately** in need of volunteers to help.

### PHILLIP ISLAND NATURE PARK REPORT Matthew Jackson, CEO and Rosalind Jessop, Environment Manager

Our Annual report was approved and a summary published in all local papers a great year for both conservation and tourism. Visitors Numbers to all parks year to date are 243,215 as against 234,661 same time for 2012.

- Awards: the Nature Parks was successful in winning the Coastal award for saving the Summerland Peninsula with the park winning this key award 2 years in a row. The park was also a winner at the Banksia Environmental Foundation awards in partnership with Victoria University for the 'magic wand' treatment for oiled seabirds. PINP has the best record for winning Banksia awards over the past 25 years of Banksia history winning in 2002, 2011, 2013 and the Gold Banksia also in 2002. PINP was also a finalist in the Premier's awards for saving the Summerland Peninsula.
- Koala Conservation Centre now has a 37.5kw solar system installed, which will generate up to half the power needed there. Our Next solar focus will be at the Environment, Education and Research pods.

- Our Boat experience tour tender process is now complete and a preferred tender is going to the board next week.
- Churchill Island Key Area Plan is now going to the board in November with community consultation to follow.
- Following the Churchill Island plan will be the South and North Coast beaches Key Area Plan and this will hopefully commence before Christmas.
- The Ian Potter foundation has granted \$192,000 towards the parks fox eradication strategy.
- A proposal has been submitted to RACV to fund the Flynns beach boardwalk upgrade.
- Summerland internal roads will now be transferred to the Nature Parks by Bass Coast Shire Council (excluding the south coast road) and a new gate will be installed (the same design as existing gate ) and opening and closing times will remain the same as currently in place.

#### CULTURAL TOURISM SUMMIT

PINP hosted the Cultural Tourism Victoria summit at the Nobbies on Friday 15 November, where PINP CEO Matthew Jackson was one of the keynote speakers. CI curator Christine Grayden attended. The summit theme was "Cultural Tourism: Driving Destination Development", and speakers covered such topics as developing iconic art museum buildings, statistical update on tourism in Victoria, maximising cultural assets to share destination stories, technology and cultural tourism: delivering authentic experiences, and attracting and servicing Chinese visitors.

Christine found the day to be a good mix of inspirational ideas and examples of practical application, and was grateful to PINP for enabling her to attend.

#### MINUTES OF THE GENERAL MEETING HELD ON November 9, 2013 at 1.30pm.

1. Welcome: President Stella welcomed members and acknowledged the indigenous people past and present. Stella also welcomed Terry Holman, past president and Life Member, to the meeting.

3. 4. CEO Matt Jackson's report delivered by Dr Roz Jessop, Environment Manager.

Annual report completed and a summary published in local papers. Numbers 243,215 so far this financial year as against 234,661 same time for 2012, so around 10k up which is great. Awards: Coastal award for Summer land winner, 2 years in a row. Banksia winner along with Victoria University for the 'magic wand' treatment for oiled seabirds. PINP has the best record for winning Banksia awards in 25 years. PINP also finalist in Premier's awards for Summer lands.

5. Previous minutes 10.8.13. David Maunders/Ruth O'Dea *carried.* 

#### 6. Matters Arising:

Report from Tom O'Dea (Membership secretary) on Member Preferences initiative: Received only 88 replies, although there was a default position for members with email to not reply if they were happy to receive items by email and for those without email to continue receiving mail by post. 91% of those with email opted for emailed notifications, newsletters, etc. Now 123 members will receive emails and 67 by post. Has been costing us \$2400 p/a for printing/postage/stationery, we will now save approximately \$1500 p/a. Previously cost us \$13 per member, should now cost \$4.60 per member. Renewal notices sent by email can still be paid by cheque or money order. No need to pay online if don't want to. i.e. payment options are unchanged regardless of how the membership application is communicated to members.

Tom explained background to the changes to the FOCIS constitution in order to comply with the new Act, and

the need to simplify our principal purpose in order to re-apply for tax deductible donation status. Necessary changes have previously been circulated to all members. Stella thanked Tom and Ruth for all of the work on the constitution.

"That this meeting adopts the Proposed Rules which have been published on the Society's web site and summarised in a document sent to all members". Moved Stella Axarlis/ 2<sup>nd</sup> Ann Jelly. *Carried unanimously.* 

Christine and Tom now need to submit form and supporting documents. Consumer Affairs Victoria will get back to us if they are not satisfied, in which case we will have to change our constitution according to their direction. Once approval has been given we will proceed to resubmit our application for tax deductibility.

Pavers under farm machinery – to be done in the next month.

#### 7. President's Report:

Stella stated that she may not be able to continue as president after the next AGM due to health problems and distance, although she acknowledged she had been able to be a conduit between FOCIS and the PINP Board. The CI Key Area Plan may contain some contentious items but was strongly for heritage. She regretted difficulties with space for the display but due to heavy losses with CI in the past, retail was necessary. She is highly committed to a museum for CI but the island still needs to generate revenue. Stella urged all members to attend the Key Area Plan community information session and have input. She was extremely pleased when the Environment Minister Ryan Smith drove to Phillip Island for a recent PINP board meeting to thank Stella for her 10 years of service. The board is working very well and is a cohesive unit, plus good leadership being shown by Matt Jackson, CEO and the other managers.

8. Treasurer's/Membership Report: See attached. Tom will transfer the costs of the pavers to go under the historic farm machinery from Curator's Expenses into a separate category.

#### 10. General Business:

Members agreed that a letter of thanks be sent from president Stella to Bob Baird thanking him for his generous donation of Pat's books.

Members also agreed that a letter of thanks be sent from Stella to Cheryl Stratford thanking her for the wonderful costumes she supplies for display at Amess House, which add so much to visitors' experience.

David stated that Greg the gardener had done a lot of clearing in the homestead garden and the flagpole to the east is now visible again. David will put an article in the newsletter asking for garden volunteers.

#### 11. Speaker:

PhD candidate E Rebecca Sanders gave a talk on the significance of the 1801 garden planted on Churchill Island. The historical record would indicate that the event was not that significant, even though it is used in the significance statements for Churchill Island on the National Trust and Heritage Victoria registers. The real significance of Churchill Island is that it demonstrates that there are many different ways in which settlement occurs.

# THE MEMBER PREFERENCES INITIATIVE Tom O'Dea, Membership Secretary

The Member Preferences initiative has been a great success with a large number of members willing to accept items by email.

Members were invited to nominate their preferences for receiving communications from the Society by email or post in each of these 4 categories:

- 1. Documents about Annual General Meetings and Special General Meetings.
- 2. Membership renewals and reminders.
- 3. Other correspondence.
- 4. The FOCIS Newsletter.

We sent a total of 93 letters and 113 emails to members and we received 88 replies. If a member did not respond, then the following assumptions were applied:

- If the member has given us an email address, then email for everything is assumed.
- If the member has not given us an email address, then everything has to be sent by post.
- A number of members who had not previously given us an email address have now done so. We now have 73% of members with email addresses.

Based on the members' explicit or implicit preferences, we have a high level of acceptance for email (about 91% of members with email addresses). For example, we have 190 members eligible to receive the newsletter. 123 members will be receiving the newsletter by email and 67 by post. This represents a significant reduction in costs. This is 65% by email and 35% by post. The numbers for the 3 other types of communications are very similar.

We spend about \$2,400 per year on printing, postage and stationery. This is mainly for the printing and posting of the Newsletter, sending out renewals and reminders and sending out membership cards. Since we will now be sending about 65% of items by email, this means that we can expect to save about \$1,500 per year.

In fact, it costs us almost \$13 per membership per year in printing, postage and stationery. Since the concession membership rate is currently \$10 per year, this situation is not sustainable. However, the cost of printing, postage and stationery per membership per year for all types of membership will now be about \$4.60 instead of \$13. This will help keep the membership subscriptions at the current levels.

Two important points to remember:

There is no change to methods of payment. You can still choose to pay your membership subscription by cheque, money or online regardless of whether you have chosen to receive membership renewals and reminders by email or by post.

You can change your mind at any time. If you find that you would rather receive a particular type of communication from the Society by email rather than post or vice versa, please contact the Membership Secretary and ask for your preferences to be changed.
