Summary:	
<ol> <li>Membership numbers are holding steady.</li> <li>We are in a healthy financial position with enough income to cover our running costs and a bit left over so we can continue to contribute to various heritage activities.</li> <li>We've paid the deposit of \$1,800 for the purchase of the Clydesdale Horse. This payment has been made from the Heritage Fund.</li> <li>A further \$8,200 is due to be paid later this month from the Heritage Fund.</li> <li>The remaining \$8,000 will be paid from the Operating Fund because we don't have enough money in the Heritage Fund to cover the full cost.</li> <li>The total cost of the horse will be \$18,000 so we need to think about how we can replenish our funds.</li> </ol>	
Re the use of money from the Heritage Fund. The Heritage Fund is referred to as a Public Fund.	
The Tax Office has very strict rules about money going into a Public Fund and money being paid out of a Public Fund. We need to make sure we comply with these rules, otherwise we will lose the tax-deductibility status of the Fund.	
Basically, the only money that can be held in the Public Fund is from donations, and interest earned on those donations. Any money in the Public Fund can only be used to further the Principal Purpose of the Association. Our Principal Purpose is "The	

promotion of the moveable cultural heritage of Churchill Island". Therefore, we need to make sure that any money paid out of the Fund complies with this requirement.	
In this case, the horse will be used for wagon rides and to demonstrate the use of the historic farm machinery on Churchill Island. Clearly, these are examples of activities that are promoting the moveable cultural heritage of Churchill Island so we are complying with the rules.
