Treasurer's Report for the Period Ending 30 June 2020

1. Summary of Results as at 30 June 2020

In summary, total nett assets grew by a modest amount of \$185 from \$27,583 as at 30 June 2019 to \$27,768 as at 30 June 2020.

During the last 12 months we spent \$4,001 on Heritage activities with a total of \$45,370 spent on Heritage activities over the last 9 years. The main item of expenditure was the Society's contribution of \$2,400 to the signage for the historic farm machinery display.

Membership numbers fell by 12 (about 8.7%) from 138 paying memberships as at 30 June 2019 to 126 paying memberships as at 30 June 2020. The total number of paying **Members** as at 30 June 2020 was 234.
