4: PINP Visitor Experience Manager Kate Adams report, Read by Leah.

Nature Parks has seen considerable changes since March including our sites closing, then reopening with limited capacities, then weekends only and now full closure once again. We are very fortunate to have received funding support from the State Government which has allowed us to maintain current staffing levels. We have recently completed our budget and business planning for 2021 and although it looks very different to our original position, we have identified a number of priority initiatives across the business.

We are now focused on deployment of staff to conservation and operational activities that are critical to our business and we are achieving some great results for the environment and wildlife and the maintenance, upgrade and protection of our sites and assets. Graeme has some photos of some of the great work that has been done at Churchill Island to share with you all. I am extremely happy to inform you that the machinery shed signs are IN.....the final installation was challenging given it had to be done with adhering to strict OHS measures. I'd like to thank Christine for the time she spent developing and reviewing the content and I have attached 2 images that Ailsa sent me. One of the priority initiatives for 2021 FY is to create new visitor experiences at Churchill Island and the Koala Conservation Reserve aimed at the domestic market given this will be the primary market for our business when travel is again possible. We have started by brainstorming ideas for what we can do at Churchill Island to ensure our visitors have a quality experience that is value for money and that we showcase the amazing heritage values of this site. We will engage with FOCIS on specific projects relating to the heritage buildings, farm and garden as part of the project.

Samantha Happe (Sam - Museum Curator) has been working from home but continues to work on the upload and digitisation of entries into the Victorian Collections website so people can learn about our collection. Sam will soon be coordinating 2 staff to research and write descriptions for contextual information about objects on the website. The information will include what it is, how it is used, why it is used and any other relevant information. This will provide depth and colour to the entries and be accessible to future researchers.





Sam is also looking into doing some oral history interviews to gather more information on some of the images in our collection. I understand she has reached out to Graeme in regards to this project. We have also ensured that basic cleaning tasks are being undertaken in the buildings on a regular basis as part of the deployment program for staff. We are keeping the drapes and doors closed while the site is closed to minimise dust and insects. Sam will continue to clean the objects as required.

Unfortunately, we are unable to restart any Volunteer programs until the restrictions change but we very much look forward to inviting our Volunteers back in the future.

The revamp of the farm machinery area has been a major FOCIS project over the last several years.

Thanks to Samantha Mather the Curator who left the role earlier this year and we welcomed her replacement, Samantha Happe. Sam Happe lives in Melbourne, but has been busy during lockdown working at home with the collection in various digital ways. Leah will also read and share Sam's report shortly.\ At the last FOCIS committee meeting in July the committee decided to review our website, and that task is ongoing at this stage. Well, what a turbulent year we have had since I last wrote to you. I am writing this report to you

from my apartment in Melbourne which I share with my husband and two very energetic kittens. We are in stage four lock d own where I am, and there is a certain amount of readjustment that we are all undergoing. My apartment is a far cry indeed from the tranquillity and beauty of Churchill Island and I am missing it very much. Hopefully you are all keeping as well as you can, and things will normalise for us all soon.

This means of course, I have mostly been working from home. I fondly remember a couple of rare

days where I was able to go to work and engage with the collection before lockdown restrictions

were reintroduced. It was wonderful to escape the confines of my place and return to the gorgeous Churchill Island

In the six months since I last updated you, I have primarily been working with our collection. I catalogued over seven hundred photographs and one hundred objects. They are accessible on the Victorian Collections website. This is the first stage of a longer project where I want to make these images and resources more readily available for the public. Due to the scale of the task it will take quite a long time. I am cataloguing these collection items, and I hope I will be able to flesh out and provide context for each item throughout the course of this year. I have been in discussions with the National Trust to look at options so that Amess House and

Rogers Cottages have a bit of a refresh of their displays. We are looking at changing some objects around and swapping furniture and decorations. This will be very exciting, and I will keep you updated.

There has also been some great research being undertaken by the Royal Australian Artillery Historical Society into our cannon and trying to demystify its origins and provide a bit more concrete information about its manufacture and introduction to Churchill Island. This has slowed since COVID 19 but we will see if they are able to pick it up when they are able, and I will provide a summary of their findings.

Thank you very much and I hope to be able to see you on Churchill Island very soon.

Treasurer's Report for the Period Ending 30 June 2020


1. Summary of Results as at 30 June 2020

In summary, total nett assets grew by a modest amount of \$185 from \$27,583 as at 30 June 2019 to \$27,768 as at 30 June 2020. During the last 12 months we spent \$4,001 on Heritage activities with a total of \$45,370 spent on Heritage activities over the last 9 years. The main item of expenditure was the Society's contribution of \$2,400 to the signage for the historic farm machinery display. Membership numbers fell by 12 (about 8.7%) from 138 paying memberships as at 30 June 2019 to 126 paying memberships as at 30 June 2020. The total number of paying **Members** as at 30 June 2020 was 234.

This is what the sales area used to look like in AH well before the PINP came along. One of FOCIS's roles was to attend the shop and sell and give info to customers in there.










